# **Polly Privacy Policy**

Thanks for visiting Polly. We value your privacy. This Privacy Policy describes how Polly Insurance Agency, LLC and our affiliates (collectively, "Polly") collect, use, share, and protect information obtained through your interactions with us, including your visits to <a href="www.polly.co">www.polly.co</a> and other websites (the "Websites"), use of our software applications (the "Apps"), and other interactions with us, such as by phone. The Websites, the Apps, and other interactions are collectively referred to as the "Services."

This Privacy Policy may change from time to time. If you do not agree with this Privacy Policy, then you should not use our Websites, Apps, or Services. Your continued use of our Websites, Apps, or Services after we make changes is deemed to be acceptance of those changes, so please check the Policy periodically for updates.

#### **Personal Information**

We collect Personal Information from and about users of the Services. "Personal Information" is information that identifies or is reasonably capable of being associated with you. # **How Personal Information may be Disclosed**

We do not give or sell your personal information to nonaffiliated third parties for their own marketing purposes without your prior consent.

We may give the personal information we collect to others to help us conduct, manage, or service our business. These parties include insurance carriers, agents, and brokers, auto dealerships, partners, regulators, service providers, persons or organizations that conduct research, insurance support organizations (including consumer reporting agencies). To may also disclose Personal Information to a third party in the event of any reorganization, merger, sale, joint venture, assignment, transfer, or other disposition of all or any portion of our business, assets, or stock (including in connection with any bankruptcy or similar proceedings), or as otherwise required or permitted by law. We take reasonable steps to ensure that our service providers are contractually obligated to keep Personal Information confidential and only utilize the Personal Information as permitted.
