

## PRIVACY POLICY

This Privacy Policy discusses what information we collect, why we collect it, how we use it, and how you can manage your information on our website. This Privacy Policy applies solely to information collected on this website for a user who has not logged into one of our applications.

### Information Collection and Use

We are the sole owners of the information collected on this site. We only have access to or collect personal information that you voluntarily give us via this website.
